3. Uploading of eligibility data within three months from the date of admission of first year students.
4. Colleges are required to carry out Permanent or Regular approval process of the Teachers who have been granted temporary approval.
5. To update Academic Online Teacher's Database of all teachers. On monthly basis review of availability of teachers shall be taken at College level & it shall be kept updated.
6. Adequate facilities regarding Hostel and Library to be provided to the students.
7. You are requested to comply with the above mentioned deficiencies within a stipulated time without fail and submit compliance report.
8. Kindly note the above and do the needful scrupulously.

Important Note:

- 1) Although the Continuation / Extension of Affiliation is granted to your College for the Academic Year 2020-21. You are not allowed to admit students for First Year Nursing Course without receipt of permission from State Government (as applicable).
- 2) In case of any irregular admissions, University shall not be responsible for any academic or pecuniary loss or damages of the concerned.
- 3) The admissions shall be done only through the Competent Admitting Authorities.
